### 1) What are the best practices for preparing a manuscript using MS Word?

### 3.) What is The ACM Publishing System (TAPS)?

The ACM Publishing System (TAPS) is an innovative framework that provides one-stop solution to submit your source files, review (and revise) the output, and approve the final version to be published. TAPS also provides an integrated helpdesk feature should you have any trouble with correctly laying out your article or interacting with TAPS. The TAPS solution will improve the publishing workflow in terms of communications with conference organizers or vendors and time-to-publish. We all benefit from TAPS in the delivery of accessibility and readability compliant delivery formats (XML/Responsive HTML5/EPUB (forthcoming.))

### 4) What are the preferred browsers for using The ACM Publishing System (TAPS)?

Google Chrome: v. 61-62

Mozilla Firefox: v. 54-55

Internet Explorer: v. 10.0-11.0

### 5) How do you access TAPS?

You will receive an email notification from TAPS giving you a unique link to use when submitting your manuscript file. This link will give you access to your author dashboard in TAPS.

### 6) Do I submit my DOCX or LaTeX file directly to TAPS?

No, your source file(s) (DOCX or LaTeX) must be submitted as a ZIP file setup according to the specific instructions given.

### 7) What is the correct file structure for the ZIP file that is to be submitted to TAPS?

The ZIP file can contain 3 folders:

**pdf:** This folder contains the PDF output of your manuscript. It is not mandatory to provide this folder.

**source:** This folder contains the final source file (MS Word or LaTeX.) This folder must contain all necessary files/resources that are required to generate the final published formats. It is mandatory to provide this folder.

**supplements:** This folder contains the supplementary material that needs to be available at the time of online publication. The content of this folder will not appear in the published PDF version. It is not mandatory to provide this folder.

After you have setup the folder(s), you the create the ZIP file for uploading to TAPS.

### 8) Is there a specific file name that the ZIP file must use?

Yes. The ZIP file name should be <Proceeding Acronym>-<Paper ID>.zip. (At the top of your author dashboard, TAPS displays the following information: the proceeding's acronym, the paper ID number,

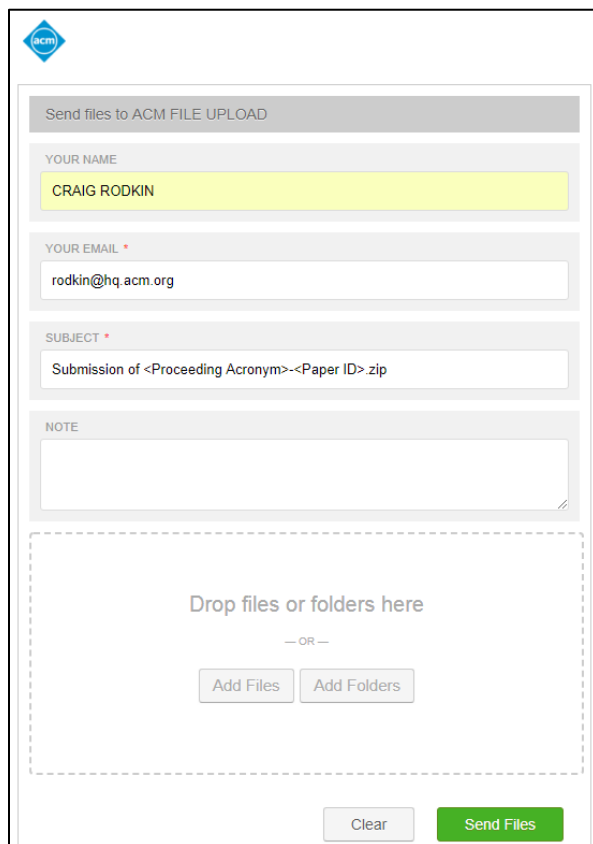
and the title of your paper.) You will also have received an email notification from TAPS specifying the file name you must use for the ZIP file.

Please also see the information available under “**General Instruction and Information**” on your TAPS author dashboard.

### 9) Is there a file size limitation to for submitting the ZIP file to TAPS?

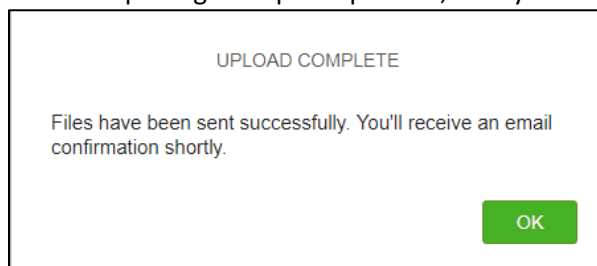
Yes. TAPS will accept a ZIP file size of 10MB or less. For larger file sizes it is recommended that you submit your ZIP file via the FTP site: <https://acmorg.exavault.com/share/view/rky6-3sc01vmn>

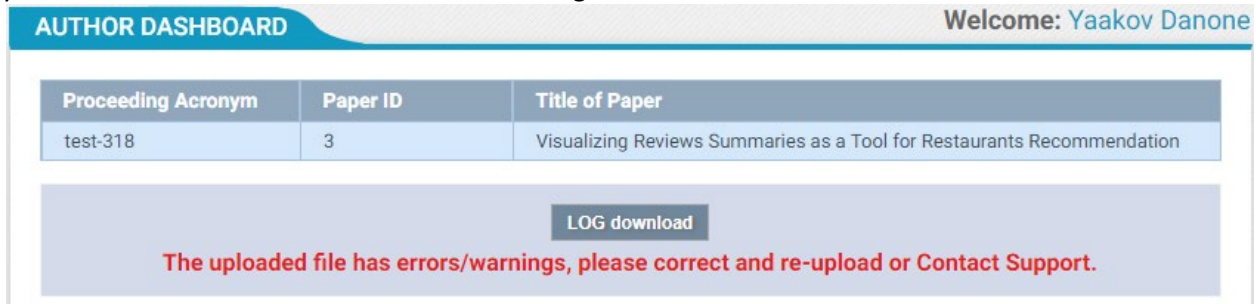

## 10) If there is a problem with my submission, how do I know what the errors are so that they can be fixed?

TAPS will perform an initial validation on the files and, if applicable, will show the error message(s) on your author dashboard as shown in the following screen shot:

## 11) How can I correct layout-related issues in the PDF output of my DOCX source file?

After successful processing of your MS Word source file you will receive a PDF proof of your article via email. The TAPS author dashboard will also show the output files on your author dashboard (within the “Download File Here” box at the right)—to correct your text for any layout issues, please follow the instructions as detailed in the following screen shot:

**For MS-Word Source Type:**

1. Download the DOC file; then download and install the Libertine font used in the published version at <http://libertine-fonts.org>.
2. Open and revise the DOC file as needed and save the file.

Come back to this author dashboard and reject the original proofs; you will then be prompted by the system to upload the revised file/files. The file will be reprocessed and revised proofs will be generated for your review and approval.

If you are unable to correct your text as needed, please select the "reject" option and the system will give you the option to contact support via the platform below.

## 12) How do I correct issues in the HTML output of your manuscript file?

## 13) How can I check the status of my manuscript in TAPS?

After the successful processing of your manuscript file you will receive the PDF output via email and the TAPS author dashboard will show the following output files on your author dashboard: PDF, HTML5, DOC, and LOG.

The LOG file will provide the details regarding the successful processing as well as the list of warning messages that occurred during the processing of your manuscript file. Please see point number 10 above to resubmit your source files post-correction to resolve warning messages.
